Message from the President of the National Catholic Board of Education write this as my short farewell address to National Catholic Board of Education and the schools' network.

When I began serving on National Catholic Board of Education I had a feeling of joy because education was and still is very close to my heart. For me to drive almost three hours from Mtubatuba to the Airport in Durban, flying from there to Johannesburg for NCBE meetings was quite a challenge. Sometimes after the meeting I had to leave the airport in Johannesburg late in the afternoon and get to Durban after 7 pm. From Durban Airport I would still take a long drive to Mtubatuba reaching home around 10 pm. This was at times challenging but it gave me satisfaction because Catholic education means a great deal to me.

What really stood out for me was the family atmosphere that I experienced in National Catholic Board of Education. All our discussions led to action. The climax was when we organized a very successful National Catholic Schools Congress which took place in Johannesburg in September 2019. It was very encouraging to see scores of teachers committing themselves to good quality education for the children of this country. Little did we know that, in a few months time, the COVID 19 pandemic was going to cause a deadly havoc not only to the citizens of this country but to the education sector in particular. The COVID 19 pandemic even claimed the lives of teachers who had attended the National Catholic Schools Congress. This became a time of fear, panic, doubting the future, and

God's grace and mercy have spared us to this day. In the midst of it all, we were encouraged by the publication of the book on the Global Compact for Education to which we had made valuable contributions.

Message from the Chairperson of the National Catholic Board of Education

ooking back over 2021, I am struck again at how we have come to view normalcy: and from where we have sourced our sense of the ordinary and every day in the education sector. Children returning to school full-time? Having 15-minute mask-breaks? Checking temperatures? C.H. Spurgeon has one view on hope: Hope ... is like a star – not to be seen in the sunshine of prosperity, and only to be discovered in the night of adversity. And then Isaiah 40.31 reminds us that we are a faith community: But those who hope in the Lord will renew their strength. They will soar on wings like eagles; they will run and not grow weary, they will walk and not be faint.

The National Catholic Board of Education (NCBE), the governance

structure of the Catholic Institute of Education, is happy to report on the ongoing systematic and communitybased service in the area of valuesbased education, and in particular of Religious Education, pastoral care, and all the many aspects that define the work of an organisation committed to the support of Catholic Schools and skills centres.

It is inevitable that over these past months and years, much of our time has been in the pastoral support of schools, personnel, and children: Covid fatigue and anxiety, running a dual system, work pressure, stress. Against this backdrop has been the identification of a number of concerning aspects: such as quality education needing to be accessible to every child (the gap is massive between those who have been able to continue with their education, and those who have fallen through the cracks); such as the right of the child to be happy and safe (the increase in racism and 'othering' is of deep concern); such as the emerging body of data on learning poverty; and such as the lack of healthy socialisation of especially the very young. Where will our children find a safe way to grow their resilience, coupled with a sense of care for others? Our Congress Direction Statements, and the Strategic Plan that emerged from them, give us guidance on where we need to reflect going forward, and what actions to undertake. Learning is a sacred action, and we can still learn.

We are educators, explorers, seekers after truth and value. It is time to make choices about whether we permit Covid to be the determinant of our lives. We hear quite often "we are in a time of transition". It is the nature of history that we are always in a time of transition. Covid is there, and will be for a long time. So our call is to discern how we can help towards equilibrium, common good, even happiness and peace of spirit, rather than running after a reality that will never return. "May the God of hope fill you with all joy and peace as you trust in him, so that you may overflow with hope by the power of the Holy Spirit." Romans 15:13

Catholic Institute of Education Director's report

e are all in the same boat" said Pope Francis as he delivered a homily of hope on 27 March 2020, comparing the COVID -19 pandemic to a storm that can be overcome only by coming together in faith.

The image of "being in a boat on a stormy sea" was the reality of 2020 and "persevering in hope" was the guiding principal for the work of CIE during 2021.

In 2020, the first two waves of the pandemic made life difficult for school communities as the state policy in response to the virus changed school life. At the beginning of 2021 the 3rd wave affected school communities far more as children and young people were more susceptible to the Delta variant which was more infectious and thus spread more rapidly.

According to Professor Lucie Cluver from the University of Cape Town and Oxford University, current research estimates that one in every 200 South African children have lost a primary caregiver. This has enormous implications for schools and communities. In addition, many teachers lost their lives to COVID 19 leaving school communities not only bereaved but necessitating extra work for those left in the school, exacerbated by efforts to 'catch up' lost learning.

CIE believes that an expression of the ethos of a Catholic school is to be open and curious about Covid-19 as a way of addressing the fear and anxiety surrounding the pandemic.

The vaccination of teachers and CIE staff members (between April and October 2021) facilitated the return of CIE to working in schools. CIE recognised the need for psychosocial support for teachers and factored this into CIE's plans for 2021.

Despite grappling with the impact of COVID-19 on their own personal lives, they continued to support Owners, Principals, and Educators to ensure that schools and skills centres remained cared for and functional and felt the strength of belonging to the Catholic Education network.

The Board's report

The National Catholic Board of Education (NCBE) is an Associate Body of the Southern African Catholic Bishops' Conference (SACBC) and reports to the Department of Christian Formation, Liturgy and Culture. The NCBE as the governance structure of the CIE met three times, the Executive a further three times and the Annual General Meeting was held in March 2021 The NCBE has 10 members a Bishop appointed by the SACBC as the President and Education Liaison Bishop; a Bishop who is an Owner of schools, elected by Bishops who are Owners; a member of the Leadership Conference of Consecrated Life (LCCL) Executive; 2 other Owners (Congregational Leaders or qualified representatives); a Schools' Trust Chairperson; the CIE Director; a Principal of a Catholic Public School on Private Property; a Principal of a Catholic Independent School; and external experts, one in finance and one in law. This ensures that there is adequate representation of all stakeholders at this level from the various demographics of our network. The NCBE's constitution was amended in 2021 to officially name the Board, the National Catholic Board of Education to distinguish it from the Regional Catholic Boards of Education in South Africa.

The day-to-day management of the organisation is delegated to the Directors who are supported by a Leadership Team. The Board endorses the principles in the Voluntary Independent Code of Good Governance and Values for Non-profit Organisations in South Africa. The Board abides by the principles of openness, integrity and accountability.

To assist the NCBE in its oversight role it has established three board subcommittees each with a specialist focus: Religious Education Reference group, Child Safeguarding and the Audit, Risk and Human Resources committee. The CBE Treasurer is the chair of the Audit, Risk and HR subcommittee that met five times, during 2021. The committee's focus, amongst other matters, is on risk management within the CIE. This is done by identifying, assessing, managing and monitoring all known forms of risk across the organisation. While acknowledging operating risk cannot be fully eliminated, the organisation endeavours to minimise it by ensuring that appropriate infrastructure, controls, systems and ethical behaviour are applied and managed within predetermined procedures and constraints.

The NCBE members acknowledge that they are ultimately responsible for the system of internal financial control established by the organisation and place considerable importance on maintaining a strong control environment. To enable the NCBE members to meet these responsibilities, the sub-committee sets standards for internal control aimed at reducing

the risk of error or loss in a cost effective manner. The standards include the proper delegation of responsibilities within a clearly defined framework, effective accounting procedures and adequate segregation of duties to ensure an acceptable level of risk. These controls are monitored through the organisation.

During 2021 CIE underwent its normal bi-annual financial audit. The findings and recommendations arising from the audit were reported by the Auditor to the Audit, Risk and Human Resources committee and were of a minor nature.

Financial Statement 2021

CIE Operational Expenditure for 2021 was R17, 4 million against a budget of R18,6 million. The expenditure was contained through reduction in travelling and accommodation due to various levels of lockdown and austerity measures which included not paying staff a cost of living increase and a bonus in 2021 and not filling vacant positions.

CIE has built up reserves over many years through a conscious policy and practice of setting aside unrestricted funds. The motivation to set aside these funds is to drive the financial sustainability of the organization and the COVID 19 pandemic raised such a crisis. To meet all CIE's financial obligations the reserve was accessed during 2020 and 2021.
